We will have a DJ providing music and entertainment, beautiful classic cars, trucks, and motorcycles to look at, and hopefully gorgeous spring weather! We would like to encourage car-related items, but other crafts are welcome as well.

so get your vendor form in as soon as possible to reserve a space!***

**(These booths are 10x12, open-air street spaces) – check/cash/credit**

### Rules & Regulations

1. Vendor application is for SATURDAY, APRIL 29, 2017 ONLY.
2. All vendors must submit a signed and dated application form—**along with your full payment**—to the Chamber office by **April 18, 2016**. Payment must be made in cash or check.
3. Vendor applications are subject to approval and acceptance.
4. *ALL applications are considered ACCEPTED unless you are informed otherwise by the Vendor Committee.*
5. Vendors will be notified of their space number. Please be sure and include an E-MAIL ADDRESS as this is the preferred and fastest method of communication.
6. Vendor setup is between **8-8:30 a.m. on Saturday**. Please get your vehicles off the square as soon as possible.
7. We ask that vendors stay until the car show awards are presented at around 3 p.m.
8. Vendors are responsible for providing their own tents, tables, chairs, extension cords, etc. Please leave an entrance/exit at the front of your space.
9. All booth materials must fit within your rented space. Tents need to be straight-legged tents so they fit inside your space.
10. Placement of booths will be at the discretion of the Vendor Committee.
11. All vendors are responsible for the security of their goods. The Chamber of Commerce and Bois d'Arc Spring Car Show Committee accept no responsibility for stolen or damaged property, accidents or injury.
12. Each vendor is expected to clean up their space at the end of the day.
13. **PROHIBITED ITEMS:** stink bombs, poppers or similar items. No knives or toy weapons may be sold—this includes potato guns and sling shots—unless otherwise approved by the Vendor Committee (call us about collector knives, etc.). No drug paraphernalia or drug emblems, or items with inappropriate language or nudity, will be allowed for sale or giveaway. No real/imitation/substitute tobacco products will be allowed for sale or giveaway.
14. **Vendors may not give away items being sold elsewhere at the festival by other vendors (such as bottled water, drinks, food, etc.)**
15. If you have an emergency or require assistance during festival hours, please locate one of the Committee members (we will have two-way radios so you can spot us).
16. The Vendor Committee reserves the right to revoke or refuse to grant booth space at any time, without recourse by the participant. The Vendor Committee also reserves the right to change/move a vendor if circumstances make it necessary.
17. All vendors **must** enter the square at the **south side entrance on Washington Street (by Chase Bank)**. Someone will direct you to your booth location
18. ***Signature on the application is required and states that vendor is aware of all rules and regulations and agrees to abide by them.***
19. You **MUST** provide us with your Sales Tax ID number. It is your responsibility to acquire a Texas Sales Tax permit with the Texas State Comptroller's office. We are not responsible for collecting or remitting your sales totals or tax.
20. The Bois d'Arc Spring Car Show events may be cancelled after commencement due to acts of God or other actions that may endanger any participants or vendors.
